Targeted Case Management | Helping individuals obtain their good life

Notable achievements include the establishment of a new Host Home in Johnson County and securing funding to broaden support for individuals and families. Tenured team members have consistently demonstrated leadership qualities, contributing to the overall strength of the team. In the realm of leadership, seamless transitions and mentorship have been key elements. The entire team has shown remarkable resilience in the face of changes, advocating for necessary modifications at both the state and agency levels. As we look forward, we express gratitude for the team's collective commitment, resilience, and perseverance. Community Resources and Outreach | Creating awareness and opportunities for inclusion

In 2023, the Community Resources and Outreach Department achieved significant milestones through its dedicated efforts, particularly in the success of the Family Navigation program. Designed to assist individuals and families navigating the intricate Kansas City Regional Office intake process, often a months-long and overwhelming journey, the program has successfully guided 22 people through the intake process. This accomplishment not only showcases the program's effectiveness but also highlights our department's commitment to alleviating the challenges faced by those we serve. Moving forward, we remain steadfast in our mission, continuing to ease the intake process and ensuring that our community members can access essential resources with greater ease and confidence..

Administrative Services | Developing staff to confidently provide resources and advocacy

Throughout 2023, retaining our employees through development and training continued to be at the forefront of our minds. Our Administrative Services Department evolved in 2023 with the addition of the Quality Assurance position. This new position supports audits and training to ensure our targeted case managers are supporting our individuals in the best way possible while also ensuring quality of documentation. This position also assists with new intakes so that new individuals can be directed and work toward services that could best support them from day one. Finally, the position allows for the current Director of Administrative Services to focus on human resources tasks such as agency culture, benefits and preventing burnout—all essential in terms of retaining quality staff. We're excited to continue this SPARK of development and improvement concerning training and employee retention into 2024!



ADVOCACY

In Missouri, proposed changes in funding for athome disability care, particularly the recalibration of Self-Directed Services (SDS) rates, have stirred widespread concern within the advocacy community. The suggested reduction in these rates has spurred families to vocalize their discontent, underscoring the crucial role SDS rates play in facilitating the hiring of essential direct care staff. Families assert that these rates extend beyond mere financial figures; they serve as a lifeline, enabling the provision of necessary care and support for their loved ones with disabilities. The potential impact of lowered SDS rates on the well-being of individuals with disabilities has ignited a fervent movement, with families rallying to preserve a system they deem indispensable for ensuring the quality of care and assistance. Advocates emphasize the importance of maintaining SDS rates to sustain the critical support network that empowers families to navigate the complexities of at-home disability care effectively. In alignment with this cause, the Johnson County Board of Services stands in support of our families who are advocating for the retention of current SDS rates, recognizing the vitality of these rates and their role in enabling families to hire essential staff. The strength of SDS lies in empowering families and individuals to take charge of their care.

FAMILY FIRST

Targeted Case Management Lead, Shelly Taylor, dedicated over a year collaborating with one of our individuals and his parents to obtain specialized care for their adult child. The parents needed a lot of support because their child needed constant care, making everyday life tough. Shelly worked hard to get support by gathering important information for a Comprehensive waiver. Things got tough when the first attempt failed, but Shelly didn't give up. She appealed and, after a rough emotional ride, found out the individual's needs didn't score high enough for the waiver.

Despite this, Shelly stuck by the family, gathered more information, and did another assessment, this time getting a higher score. With a newfound hope, she got the waiver approved, giving the family a break, and putting the individual on the wait list. At the same time, Erica Wilson, our Quality Assurance lead, saw how difficult it was for the parents. She helped Shelly by finding a provider for Individualized Supporting Living services through Abilities LLC, which meant he was able to move out of his parent's home and into his own.

This change was big. The individual became more independent, and the parents didn't have to be full-time caregivers anymore. It meant the family could enjoy being a family without the heavy weight of constant care. It was a big win, not just on paper, but in real life.





COMMUNICATION


In 2023, we continued our Get to Know Me series, spotlighting different individuals and their families. One of our favorite videos from this year was about Brandon Brown. His mother, Laura Brown, walked us through her journey towards finding out Brandon was diagnosed with Down Syndrome and who he's become today. One of our favorite moments from this video is when Laura is explaining that the medical staff asked if she knew what to do with a child who had Down Syndrome. She replies, "raise him like normal?"

These stories serve a purpose, fostering empathy and providing valuable support for families navigating similar paths. The importance of these stories lies in their ability to reassure others that they are not alone. By sharing experiences, we promote understanding and resilience, emphasizing that, despite the challenges, families can navigate the developmental disability world.

Laura's perspective reinforces the idea that, with the right support, every individual has a unique and valuable role in our community.













SB40 FUNDING HIGHLIGHT

In 2023, JCBS proudly supported equine therapy at The Barn Therapeutic Riding Center in Leeton, by providing scholarships for individuals who have developmental disabilities in Johnson County. By providing scholarship opportunities we've been able to help this organization make a profound impact on the lives of people with developmental disabilities. One of our favorites stories is about Finnean, a scholarship recipient who is diagnosed with muscular dystrophy.

Due to this diagnosis, Finnean lacked core strength which greatly affected his speech. Riding horses can greatly increase your core strength due to the rider constantly moving and switching positions to stay upright. Since the age of 3, Finnean has participated in equine therapy with his speech therapist. Befriending a horse named Bucky, Finnean found not only a new friend, but a source of inspiration for his speech development. From whispering the one syllable words "Buh" and "Kee" to clearly uttering Bucky's two syllable name within a few short weeks, Finnean was already making huge strides with his speech goals. While at the farm, Finnean also befriended an abandoned cat. This bond became so profound that, during a lesson, Finnean surprised everyone by asking, "Kitty ride too?"

Finnean's progress has truly been a testament to the power of equine therapy. We are privileged to have supported Finnean and his family during this journey and appreciate the service this wonderful agency provides.
