At JCBS, we value transparency, I'd like you to know how we use public funds to support individuals with developmental disabilities right here in our community. JCBS is primarily funded through local tax dollars and a state Medicaid contract. Every dollar we receive is invested back into the people, programs, and services that make Johnson County stronger and more inclusive. The largest portion of our budget goes to Targeted Case Managementwhere our case managers work directly with individuals and families to build person-centered plans, connect them to supports, and advocate for their needs. We also use local funding to match Missouri state Medicaid dollars for the Partnership for Hope Waiver and fund the JCBS Waiver, which helps pay for respite care, transportation, and summer camps.

Beyond waiver support, JCBS proudly invests in community programs that promote inclusion and accessibility. In 2025:

- We awarded **\$485,000** to RISE Community Services for transportation, insurance, and capital improvements
- We granted **\$8,000** to The BARN Therapeutic Riding Center to fund scholarships for therapeutic horseback riding
- And we awarded **\$20,000** to Warrensburg Parks & Recreation to move forward with Phase 2 of the Inclusive Sensory Garden Project.

Every funding decision is reviewed carefully by our Board of Directors to ensure we're making the most meaningful impact with the resources we're entrusted with.
